Participation Guide

Eligibility Criteria for selection

- The case must demonstrate a significant impact on carbon neutrality or energy transition.
- The case should have a replicable or scalable model, with potential benefits to other regions, especially in developing and least developed countries.

Submission Guidelines

- This nomination process is completely free, with no associated fees.
- Provide a detailed description of the case, including its objectives, implementation, outcomes, and impact.
- Include evidence of success, such as data, testimonials, or awards.
- Submissions must be in English and adhere to the specified format and length.

Nomination Process

- Nominations can be made by self-nomination or by nominating others.

Evaluation and Recognition

- An expert panel will review the nominations and make decision within four weeks after receiving the completed information.
- Selected cases will be featured in our website, publications, events, and digital platforms.
- Special recognition will be given at our annual conferences and other high profile occasions, with opportunities for global exposure and networking. One confirmed event is the second ISETS international conference (<https://isets.org/isets2024/>), which will be held in Nanjing, China, from November 1-4, 2024.

Deadline for Submission

- Submissions are open permanently.
- However, for those wishing to join the exhibition at the 2nd International Conference in Nanjing, China, on November 1-4, 2024, the deadline is August 31, 2024.
